Location

The shop is situated on the north side of Dumbarton Road, close to its busy intersection with Crow Road, within the Partick area in the heart of Glasgow's West End. The local area is very much an emerging location with an excellent mix of retail, coffee shops and restaurants.

The premises lie approximately 2 miles west of the city centre. The surrounding area is densely populated consisting primarily of traditional tenement properties. The premises are located to the west of the principal retailing area of Partick and are also very close to the West End Retail Park. Surrounding retailers include **Hot Doughnuts, Suissi Vegan Kitchen, Perfectly Pierced, Granny's Kitchen, Lavish West, Prosperity Financial Solutions, Glasgow Dyson Centre** and **Dicksons Chemists**.

Partick Subway and train stations are a short distance with the subjects well placed for access to the Clydeside Expressway providing quick access to the city centre and motorway network. There is on-street car parking to the front of the premises.

Description

The premises comprise ground floor retail benefiting from Class 1A office consent within a four storey red sandstone tenement.

The premises benefit from a modern shopfront with a centrally positioned glass entrance door. Electric operated security roller shutters are positioned internally. The shopfront signage is illuminated.

Internally the premises comprise a large open plan retail / office together with a private office and boardroom / meeting room to the rear including a tea prep, storage and WC.

The premises have been fully refurbished. The finishes internally are a carpet floor, suspended ceiling with integrated LED light fittings, plaster walls and modern electric radiators. The offices are formed using glazed partitions. There is air conditioning and the premises are alarmed.
